## Our Staff



## Therapy Services

### Adults

We provide therapy services for adults dealing with various issues like depression, anxiety, grief, trauma, relationship struggles, and more. Whether you need individual, family, couple, or group therapy, we're here to support you through life's challenges.

### Children and Families

We help children and families by working together with a therapist to manage challenging behaviors at home, school, and in the community. If needed, we also connect families to our Youth Community Services program to provide additional support and create a treatment team for better mental health and resilience.

### Substance Use Therapy and Recovery Services

We offer specialized therapy and recovery services for adults and adolescents struggling with substance use. Our licensed professionals are experienced in treating substance use issues, whether they occur alone or alongside other mental health disorders. We're here to provide personalized care and compassion to meet the unique needs of each individual.

## Adult Community Services (ACS)

Pawnee Mental Health provides a variety of community services for adults diagnosed with Severe and Persistent Mental Illness (SPMI). These services are tailored to individual needs and may include in-home and community-based support as outlined in their treatment plan.

### Individual Placement & Support (IPS)

Pawnee's Individual Placement and Support (IPS) is an evidence-based practice zero exclusion program, designated to helping individuals who have a mental health diagnosis explore and keep competitive employment.

### Assertive Community Treatment (ACT)

Assertive Community Treatment (ACT) is an evidence-based approach that enhances outcomes for individuals with severe mental illness (SMI) who are particularly vulnerable to homelessness, psychiatric hospitalization, and repeated institutionalization. The primary aim of ACT is to provide consumers with comprehensive community care and support, empowering them to lead fulfilling lives not defined by their mental health challenges.

### Assisted Outpatient Treatment (AOT)

Assisted Outpatient Treatment (AOT) involves providing community-based mental health treatment through civil court commitment. It aims to encourage adults with mental illness, who may struggle with adhering to voluntary treatment, to fully engage with their treatment plan. AOT emphasizes the importance of treatment providers working diligently to ensure the individual remains committed to effective treatment.

## Youth Community Services (YCS)

Youth Community Services (YCS) at Pawnee Mental Health offers a wide range of services and treatments for children and teens dealing with Serious Emotional Disturbances (SED), along with support for their families. These services are flexible, with options for delivery in the home, school, or at a Pawnee office.

## Medical Services

Pawnee provides medical services for children, adolescents, and adults, which encompass medication evaluation, medication management, and telemedicine. These services are overseen by an Advanced Practice Registered Nurse (APRN) in collaboration with a Psychiatrist (MD).

## Crisis Services

Pawnee's mental health professionals are available 24/7, 365 days a year, to respond to crisis situations for individuals of all ages, including children, teens, and adults. We offer a variety of services tailored to meet each individual's needs, including crisis assessments conducted in emergency rooms, jails, and within the community.

### Crisis Stabilization Unit (CSU)

Adults ages 18 and above may be referred to Pawnee's 11-bed Crisis Stabilization Unit, located at 1558 Hayes Drive, Suite A, Manhattan KS, 66502. This unit offers voluntary treatment for individuals facing acute mental health or substance use crises.

### Mobile Crisis

The Mobile Crisis Team is a dedicated group committed to providing timely intervention and support to individuals facing behavioral or mental health crises in the counties served by Pawnee Mental Health. The team will provide crisis intervention in the field, aiming to de-escalate and stabilize an immediate crisis in the least restrictive environment possible.
